DESCRIPTION

KingAdd 75HC is a liquid admixture formulated from selected polymers specially designed to retard the setting time by controlling the hydration process of Portland cement and other cementitious materials for long time. This effect can be used to keep concrete workable for long time starting from 3 hours till three days.

COMPATIBILITY

KingAdd 75HC can be used with all types of Portland cement and cement replacement materials. KingAdd 75HC is compatible with other KINGKRETE admixtures used in the same concrete mix.

If more than one type of admixture is to be used in the concrete mix, they must be dispensed to the concrete separately.

METHOD OF USE

KingAdd 75HC should be added to the concrete with the mixing water to achieve optimum performance. Also it can be added directly to the drum of concrete mixers when unplanned changes in concrete casting schedule.

DOSAGE

The guidance dosage of KingAdd 75HC is 0.1 - 3.0 litre/ 100 kg of cementitious materials in the mix, including GGBFS, PFA or microsilica.

Representative trials should be conducted to determine the optimum dosage of KingAdd 75HC to meet the performance requirements by using the materials and conditions in actual use.

EFFECTS OF OVER DOSAGE

Overdosage of KingAdd 75HC will cause the following:

- ☒ Significant increase in retardation.
- ☒ Increase in workability.

CLEANING

KingAdd 75HC can be washed with fresh cold water.

PACKAGING

KingAdd 75HC is available in 25 litre pails, 210 litre drums and 1000 litre bulks supply.

STORAGE

Shelf life is 1 year when stored under cover, out of direct sunlight and protected from extremes of temperature.

Failure to comply with the recommended storage conditions may result in premature deterioration of the product or packaging. For specific storage advice consult KingKrete's Technical Services Department.
